Terms and Conditions

Submission of this Appliance Rebate Form is subject to the following terms and conditions:

1. Rebates will be awarded on a first-come, first-served basis until the allocated program funds are depleted. First-come, first-served status will be determined by the date the Appliance Rebate Form is received by the program administrator.
2. Appliance Rebate Form must be completely and accurately filled out. Incomplete forms will not be processed.
3. Purchaser must be a SWEPCO residential customer in Arkansas. Appliances purchased must be installed at the location associated with the SWEPCO account number listed on this Appliance Rebate Form.
4. Households (single addresses) are limited to one clothes washer rebate per household.
5. Only ENERGY STAR clothes washers are eligible. Qualifying units must be listed on energystar.gov.
6. The submitted Appliance Rebate Form must be postmarked within 90 days of purchase.
7. Customers must provide a copy of their sales receipt, which must indicate the retailer name, address, purchase date and price, proof of payment, product manufacturer, and model.
